#### **CHAIR REPORT**

Avella Collopy provided the following report as Branch Chair:

I am pleased to present the Chair report for the 2021/2022 year on behalf of the PINZ Auckland Branch Committee.

We have emailed everyone who was registered for this AGM an Annual Report, and I hope you have had a chance to read this prior to the AGM.

This past 12 months have continued to be challenging in respect to arranging normal functions, but we have managed to complete the following events;

- One half day seminar
- 3 part webinar series on various topics
- Attendance at the AUPSS Women in Property Event
- Attendance at all National Chair meetings
- Coffee mate event
- Presented the FER Noble prize at the Annual Property Departments Awards Dinner

In addition, we have recently had a meeting with AUPSS regarding a panel discussion event and how we can work more closely with Auckland University.

Given the current climate, we are reviewing how we continue to provide valuable events to our members both in person and online.

The committee has continued to be involved with both Auckland and Massey University, where we have met with Alan Pope of Massey University and Deborah Levy of Auckland University to discuss how PINZ and the Universities can better assist each-other and we have attended several events including the AUPSS Women in Property Event and panel discussions.

Boris Babic has been our PINZ Councillor reporting on all National matters, and we thank him for this.

I refer you to the membership report, where we continued to obtain many new PINZ members and I would like to thank Kelly Beckett for heading this role with help from John Churton for all their efforts in handling this task.

The Auckland Branch has recognised that as the PINZ committee we need to be more involved with the wider communities which are part of this organisation who are IPAC, COMPRO and PROMINZ. The Auckland Branch continue to work with PINZ staff, where Bronwyn Starke and Scott McLew continue to join our monthly meetings.

I would also like to thank our sponsors and those who have supported us with venues this year with these being BECA, Savills and Bayleys.

Finally, I would like to thank all the committee members for their work during the year. We have had most of our meetings on teams given COVID-19 and they have worked through issues like COVID to bring the events together.

### **CPD REPORT**

Matt Tooman provided the following report on behalf of the CPD Subcommittee:

The Auckland Branch held a selection of Continuing Professional Development events during 2021.

The first was a half-day seminar on health and wellbeing held at the Beca auditorium on 15 April 2021, with quality presentations received from Melanie Lewis of QV who opened the session with a comprehensive insight into wellbeing procedures at Quotable Value. This clearly showed a very forward-thinking organisation in having these matters at the forefront of their business planning and operation.

Dr Sven Hansen followed with a broad and insightful programme which used his extensive experience in dealing with this topic. Dr Hansen offered some techniques for individuals managing workload and maintaining a balanced life.

Bridget Smaill from BNZ provided an excellent review of BNZ's approach to health and wellbeing, with this again highlighting the forefront of its modern business thinking.

All speakers complemented each other, and a beneficial afternoon was had by the 60 attendees. Positive feedback from the event was strong.

Our second event for the year was a webinar series with three speakers on different dates. We were fortunate enough to obtain a quality presentation from John Dakin, CEO of Goodman, on 14 October, who provided a masterclass review of their business's investment strategy.

That was followed by a presentation by Simon Woodhams on 21 October who provided an insightful, quality presentation on strategic investment decision making at Property For Industry.

Our final webinar was held on 28 October, with Julie Steensen of Ngāti Whātua providing a quality overview of Ngāti Whātua's long term investment strategy.

Paying attendance was 65 for Webinar 1, 41 for the second, and 20 for the third series. In addition, up to 15 free tickets were offered to third year property students at the University of Auckland which were fully subscribed for the first, with reducing numbers for the second and third webinars.

Net proceeds from the Wellbeing and webinar events comprised some \$8,000. These funds are beneficial to our Branch's operational requirements, although overall attendance/revenue was lower than preferred. We believe this reflects a number of possibilities including the wide availability of quality presentation content available from PINZ and other organisations, the inability to carry over CPD points (CPD policy is currently being reviewed) and arguably, a saturation of options.

Organisation of the events can be challenging, particularly when circumstances mean that live performances cannot be undertaken. That said, we would like to sincerely thank those members of PINZ who assisted in hosting these events including Rebecca van Etten, Rochelle Misseldine, and Catherine Flanagan. We would also extend our gratitude to Bronwyn Starke who is an unflappable host of webinar events. Beca have also been fantastic at providing their auditorium free of cost, with audio-visual equipment, tea and coffee options, and guest speaker parking available.

I have offered my resignation from the CPD role after the next event however would say that I have been pleased with the quality of the programme that has been offered to Auckland Branch and more recently, national members. I would hope that a more structured CPD calendar could be created through PINZ HQ, as often overlapping events occur, and that event financials could be more readily available.

### **BOARD MEMBER'S REPORT**

Boris Babic provided his apologies. Avella provided the following National Board Member's report on his behalf:

Looking back, 2021 proved to be nearly as tumultuous as 2020 with the reemergence of COVID-19 and its associated measures. Nevertheless, the Board was able to provide the wider membership with an open view to the new strategic plan which will guide the Property Institute into the future. This process took many months and multiple iterations through workshops, surveys and direct member feedback which eventuated in an overarching goal to become 'The Home of Property Professionals' following the initial twenty years of operation. The strategic plan focuses on key values of professionalism, collectivism and ethics which aim to provide public confidence, deliver specialist knowledge, and provide a lifelong career path for our members from graduation to retirement.

The year in review also provided arguably the most successful national conference to date hosted in Auckland. For all those that attended it was clear we were treated with a range of highly respected and intriguing speakers. Throughout this period the Board was also able to welcome new members which will look to strengthen the leadership of the Board and provide a diversity of thought.

Strong leadership from our CEO Viv Gurrey enable the National Support Team to continue delivering on key infrastructure improvement measures covering communications, CPD and general administration to the various branches.

From a local level, we continue to deliver messages from the Auckland Branch committee to the PINZ Board to ensure your voices are being heard. Many thanks go to Phil White for his services over the past year. I encourage all members to reach out to the branch if there are issues you feel need to be discussed.

We look forward to the opportunities of 2022 ahead.

### TREASURERS REPORT / FINANCIAL STATEMENTS

Avella Collopy presented the financials on behalf of the Treasurer Alex Dolejschka-Ang and referred members to the Annual Report which contains the financial reports.

Overall, 2021 was similar to 2020 being a less active financial year due to the ongoing impact of the COVID-19 Pandemic.

The main points to summarise are:

- We had income of \$25,647.14 with expenses of \$23,848.99, leaving us with an operating profit for the 2021 financial year of \$1,798.15 versus an operating profit in 2020 of \$1,494.97.
- Most seminar events which were able to be hosted at a profitable level. Unfortunately, only one Young Guns event was held and was at a breakeven level.
- As of 31 December, we had \$22,612.89 of working capital, \$21,601.33 in a term deposit and accounts receivable of \$666.71, totalling current assets of just over \$44,880.93.
- Our current liabilities as at 31 December comprised of accounts due for payment in the new year, totalling \$0.
- This leaves us with net assets and total equity of approximately \$44,880.93 for 2021 vs \$45,769.80 in 2020.

Please note that these figures are GST inclusive.

Overall, taking into account the impact of COVID-19 in 2021 the branch position has remained stable and of a good financial position with similar amount of cash on hand in comparison to 2020 and 2019. The largest one off payment was in regard to Young Guns expenditures. Other successful events includes the Half Day Seminars organised with the help of Matt Tooman.

The branch hopes to carry on with another successful year for 2022 with the easing of COVID rules to be able to host more events and seminars.
